or defense of legal claims. KTB may not delete or destroy your personal data for legal obligations under Section 33 of the
PDPA.

 - 6.1.3 KTB must decline your request according to the law or court order.
- 6.1.4 Your request is unreasonable such as you have no right to request or you have repeatedly requested the same or similar right without a reasonable cause.
- 6.2 When KTB receives a request to exercise any rights from you, KTB will process such request as soon as possible and will inform you of the status of your request.
- 6.3 If KTB declines your request on reasonable and lawful grounds as specified in item 6.1, KTB will inform you of the reason for such decline though your selected channel specified in this form and deliver to the Data Subject at the address or email address in item 1, or to the Authorized Person of the Data Subject at the address or email address in item 2. Whereby, KTBCS is not responsible for any loss or misdeliver during the postal service, or disclosure of personal data to and by your family members.
- 6.4 KTB may contact you to collect additional information or document if your request is ambiguous or you did not provide sufficient information or document for KTB to process your request.
